PROPOSTA

Premesso che sul Sito Internet del Programma Comunitario di Cooperazione Interregionale INTERREG IV C 2007-2013 il 25 ottobre 2010 è stato pubblicato l' Invito a presentare proposte con scadenza fissata 1° aprile 2011, in lingua inglese (lingua comunitaria), che prevede la presentazione di progetti di cooperazione interregionale sulle seguenti priorità:

1. Innovazione ed economia della conoscenza;
2. Ambiente e prevenzione dei rischi.

Considerato il Programma Comunitario di Cooperazione INTERREG IV 2007-2013 ha come obiettivo migliorare, attraverso la cooperazione interregionale, l'efficacia delle politiche di sviluppo regionale nelle aree dell'innovazione, economia della conoscenza, ambiente e prevenzione dei rischi, al fine di contribuire alla modernizzazione economica e alla competitività dell' Europa;

Dato atto

che la Provincia Regionale di Messina ha ritenuto opportuno aderire, in qualità di partner, all'iniziativa "Stretti d'Europa", sottoscrivendo un Protocollo d'Intesa, in lingua inglese, di cui si allega copia alla presente deliberazione, nel corso del Meeting tecnico-politico svoltosi a Calais il 23 novembre 2010 insieme ad altri rappresentanti politici di enti locali europei i cui territori ricadono sulle sponde di Stretti;

che il Protocollo d'Intesa è finalizzato a :

FOURTH CALL FOR PROPOSALS

TERMS OF REFERENCE

1. INTRODUCTION

Authorities and stakeholders at local and regional level have a vital role to play in the achievement of the EU's strategies for growth, jobs and sustainable development. The exchange, sharing and transfer of policy experience, knowledge and good practices contribute to the success of this objective.

The INTERREG IVC programme is part of the European Territorial Cooperation Objective of the Structural Funds policies for the period 2007-2013. It aims, by means of interregional cooperation, to **improve the effectiveness of regional development policies** and contribute to economic modernisation and increased competitiveness of Europe, by:

- enabling local and regional actors across the EU to exchange their experiences and knowledge;
- matching regions less experienced in a certain policy field with more advanced regions;
- ensuring the transfer of good practices into Structural Funds mainstream programmes.

The INTERREG IVC programme is financed through the European Regional Development Fund (ERDF), whose principles and regulations are laid down in Council Regulation N° 1083/2006 (General Regulation), Council and Parliament Regulation N° 1080/2006 (ERDF Regulation) and Commission Regulation N° 1828/2006 (Implementation Regulation). The principles and regulations for projects developed within the programme are laid down in the Operational Programme, which was officially approved by the European Commission on 11th September 2007.

2. ELIGIBLE AREA

The eligible INTERREG IVC cooperation area covers the whole territory of the European Union with its 27 Member States, including insular and outermost areas. In addition, Norway and Switzerland are full members of the programme and organisations from these countries are welcome to participate in it. Partners from other countries can participate at their own costs.

3. TIMING OF THE CALL

The fourth call for proposals opens on 1 December 2010 and closes on 1 April 2011.



4. PRIORITIES

The INTERREG IVC programme is divided into two thematic priorities related to the EU strategy for growth and sustainable development known as the Lisbon and Gothenburg strategies. Applicants are invited to submit their project application under one of the sub-themes listed below.

PRIORITY 1 – INNOVATION & THE KNOWLEDGE ECONOMY	PRIORITY 2 – ENVIRONMENT & RISK PREVENTION
- Innovation, Research & Technology Development	- Natural & Technological Risks, Climate change
- Entrepreneurship and SMEs	- Water Management
- Information Society	- Waste Prevention and Management
- Employment, Human Resources and Education	- Biodiversity and Natural Heritage, Air quality
	- Energy and Sustainable Transport
	- Cultural Heritage and Landscape

Further information on the programme priorities and sub-themes can be found in the Operational Programme and annex 1 of the programme manual.

5. TYPES OF INTERVENTION

The fourth call is open only to Regional Initiative Projects, excluding mini-programmes. A detailed description of this type of intervention is provided in section 2.1.1 of the programme manual. Applications for Capitalisation Projects and mini-programmes will not be accepted.

6. ADDITIONAL REQUIREMENT: THE IMPLEMENTATION PLANS

Based on the experience gained from the previous calls and further to the recommendations of the programme evaluation, an additional requirement is set for the fourth call projects in terms of outputs to be produced within component 3. In order to optimise the results of the policy exchange of experience, each 'region' participating in the cooperation will have to produce an 'implementation plan'. The aim is to go beyond the requirement of a final document like a good practice guide or a policy recommendation paper (which usually remain at project level) by focusing on a more specific output at 'partner' level.

The implementation plan is defined as a document that specifies how each 'region' participating in the cooperation will work to integrate the lessons learnt from the cooperation into its local / regional or, if relevant, national policies. This plan should describe the future actions planned to ensure that the benefits of the exchange of experience are not lost after the project ends. Examples of these actions could include: - local meetings to mobilise relevant stakeholders and to prepare bids to be submitted in local/regional/national programmes; - launch of new initiatives in the region; - measures to modify a specific policy document/instrument. The plan could also include information on the results already achieved during the project lifetime if relevant. The implementation plan should contribute to better ensure the durability of the project results.

No specific format or template for the implementation plan is provided by the programme so it is up to each project / region to set it up according to its needs and characteristics. The implementation plan reflects the intent of the regions and shall not be considered as a binding document. Nevertheless, partners are encouraged to gain the necessary commitments to put the plan into action.

This new requirement is reflected in the fourth call application form through the addition of a compulsory output indicator in component 3 (section 3.3.1). When calculating the value of this indicator, applicants need to consider that the number of implementation plans may not necessarily correspond to the number of partners. For example, if the same region/territory is represented by more than one organisation (e.g. a public authority together with its development agency), only one joint implementation plan for this region is expected from these two bodies. There may be also cases where one of the proposed partners is involved in the proposal not representing a 'region' but as an organisation whose specialised knowledge and competences (e.g. in terms of communication and dissemination or exchange of experience) are required for the success of the project. In such a case, the concerned organisation will not have to elaborate an implementation plan.

The implementation plans will have to be submitted to the programme at the end of the project, therefore an abstract of each implementation plan will have to be available in English.

7. INNOVATIVE CHARACTER OF THE APPLICATION

Since the programme has already approved 122 projects, the innovative character of the applications submitted in the fourth call will be of special importance. Therefore, authorities interested in this call are warmly invited to check the characteristics of these projects on the 'Approved projects database' on the programme website: www.interreg4c.eu

In case of similarities with approved projects, applicants will need to precisely explain in their application form the differences but also the possible synergies of their proposals with these projects. The similarities can be related to the topic tackled by the proposal but they can also be related to the partners involved in the cooperation. The innovative character of fourth call applications will need to be clearly demonstrated at both levels.

An analysis of the current thematic and geographical coverage of the programme is also available as part of the external evaluation, available on the programme website under 'Programme > Programme evaluation'.

8. PROJECT DURATION

Decisions on fourth call applications are expected to be taken by the end of 2011. The applicants should therefore be ready to start their project in January 2012.

Since all activities within the projects must be completed and costs paid before the end of 2014 (see also section 2.4.1 of the programme manual), the fourth call projects will last a maximum of 36 months (project closure included) without any possibility of extension of duration.

9. PARTNERSHIP REQUIREMENTS

9.1 WHO CAN APPLY?

Only public authorities and bodies governed by public law are eligible. According to Directive 2004/18/EC, Article 1, a body governed by public law means any body:

- (a) established for the specific purpose of meeting needs in the general interest, not having an industrial or commercial character;
- (b) having legal personality; and
- (c) - financed, for the most part, by the State, regional or local authorities, or other bodies governed by public law;
- or subject to management supervision by those bodies;
- or having an administrative, managerial or supervisory.

Only "official partners" (those listed in the application form, also called "contributing partners") can incur costs and receive ERDF. It is therefore not possible to participate with a "sub-partner" status.

As indicated in the Operational Programme and programme manual, applications from national, regional or local authorities, or partnerships having at least a solid and relevant participation of regional and local authorities in them, will be considered with priority in the selection process. In order to maximise the impact of this programme on regional and local policies across the EU, applicants are strongly encouraged to include the relevant and competent public authorities in their application.

9.2 GEOGRAPHICAL COVERAGE

In order to be eligible, the applications submitted in the fourth call will have to ensure that the two following requirements are met:

- **at least one partner from each of the four Information Point areas** (see point 14 below) is represented in the partnership,
- **at least one of the twelve most recent EU Member States** is represented in the partnership (i.e. Bulgaria, Czech Republic, Cyprus, Estonia, Hungary, Latvia, Lithuania, Malta, Poland, Romania, Slovakia, Slovenia).

10. FINANCIAL SIMPLIFICATION

In order to simplify the reporting of **administration costs**, a flat rate has been introduced for projects to be approved under the fourth call.¹ This will simplify the reporting and first level control and audits of administration costs as no supporting evidence is required to back up the reported administration cost amount.

In the application form for the fourth call, the administration budget is now automatically calculated as 12% of the budgeted staff costs. **The same single fixed rate for administration costs (12% of staff costs) applies to all partners in all states participating in the INTERREG IVC programme.**

For the budgeting (and later reporting) of staff costs, and the costs under the other budget lines, the real cost principle continues to apply. Further explanation of this financial simplification is available in the programme manual section 2.4.2.2.

¹ In compliance with Article 7(4) of Regulation (EC) No 1080/2006 as amended by Regulation (EC) No 397/2009 and subject to the positive outcome of the EC's ex-ante assessment of the proposed method.

11. FUNDING AVAILABLE AND CO-FINANCING RATE

The remaining available ERDF budget for projects is allocated to the fourth call for proposals. This ERDF budget amounts to approximately **EUR 100 million** (around EUR 62 million for priority 1 and 38 million for priority 2).

Under the INTERREG IVC programme, the eligible project activities are co-financed by the ERDF at a rate of either 75% or 85% depending on the Member State. Partners from Norway and Switzerland are not eligible to receive ERDF but can receive co-financing from their respective national funds. The Norwegian funds are provided directly through the programme and the co-financing rate amounts to 50%. Swiss partners should refer to the Swiss National Contact Point in order to know more about the availability of Swiss funds.

12. APPLICATION PROCESS

The application pack of the fourth call is available on the programme website (www.interreg4c.eu) and includes the following documents:

- the present terms of reference,
- the programme manual,
- the application form,
- the application form technical requirements,
- the co-financing statement template.

Project applicants who would like to submit a proposal must complete an application form in English, as it is the working language of the programme. Applications submitted in another language will be considered ineligible.

The application form is an Excel document, programmed with a number of automatic links and formulae. These features ensure that error messages appear in the form if it is not properly filled in. Applications submitted with error messages will be declared ineligible. Detailed instructions on how to fill in the application form are provided in the form itself and in the accompanying notice of the application form technical requirements. The electronic version and paper version of the application form must be identical. The original paper version of the application form must also include the signed co-financing statements from all partners including that of the Lead Partner (originals or copies).

Further requirements are outlined in point 13 below and in section 3.4.1 (eligibility criteria) of the programme manual.

13. SELECTION PROCESS

All applications will be subject to a two-step assessment procedure. Applications will initially be checked against the following eligibility criteria.

Fourth call eligibility criteria
1. Has the application form been <u>submitted in due time</u> in original and electronic versions, both versions being identical? Is a proof of sending provided (postal stamp or equivalent)? 2. Is the <u>application complete</u> and include: - the application form (original)? - the co-financing statements for the Lead Partner and each partner (originals or copies)? 3. Is the <u>application form dated and hand signed and fully and properly filled</u> in according to the instructions (no error messages appear in the document)? 4. <u>Are all co-financing statements correct?</u> Are they signed and dated (they should also be stamped and printed on headed letter paper if available)? Is the name of the partner mentioned identical to the institution name mentioned in the application form? Does the sum stated in the statement at least cover the "national co-financing" amount (or the "total amount" in case of partners not applying for INTERREG IVC co-financing) indicated in the application form? Is the standard form included in the application pack used and, besides the fields to be filled, have no amendments been made to the text? 5. Does the project partnership include <u>at least one partner from each IP area</u>? 6. Does the project partnership include <u>at least one new EU Member State</u>?

The eligibility assessment is a 'yes or no' process. This means that the eligibility assessment does not allow any flexibility in the way the criteria are applied. Applications that do not meet all the eligibility criteria will not be considered further.

Eligible applications will be subject to **quality assessment** according to six selection criteria which are further detailed in annex 4 of the programme manual:

- Content-related criteria
 - Criterion 1 - Relevance of the proposal
 - Criterion 2 - Coherence of the proposal and quality of approach
 - Criterion 3 - Quality of results
- Implementation-related criteria
 - Criterion 4 - Quality of management
 - Criterion 5 - Quality of partnership
 - Criterion 6 - Budget and finance

Based on the results of the quality assessment, final decisions are made by the Monitoring Committee of the programme, which is made up of representatives from both national and regional authorities within the participating states. They are communicated to all Lead Partners via a notification letter.

14. TECHNICAL ASSISTANCE

The Joint Technical Secretariat (JTS) - which supports the Nord-Pas de Calais Region, Managing Authority of the programme - is based in Lille, France. The JTS is in charge of the overall implementation of the programme (development, assessment, monitoring, auditing). The JTS works closely with four Information Points located across Europe. They provide assistance to applicants and organise events to promote the programme. They also support the network of national and regional contact points. Applicants are invited to get in contact with their respective Information Point depending on their location (see table below).

2.3.2. Partnership funding

2.3.2.1. Funding for partners from EU-Member States and from Norway

Under the INTERREG IVC programme, the eligible project activities are co-financed from the ERDF at either 75% or 85% depending on the Member State in which the partner is physically located (determined by its address). The other 25% or 15% has to be provided by the partners themselves. The sources of the partners' own co-financing amount can be manifold. It can come from the partners' own budget, or from other public sources at central, regional or local levels.

It is not possible to receive an advance payment from the ERDF under the INTERREG IVC programme. This means that each project has to pre-finance its activities until it submits a progress report and claims funds from the programme for the activities carried out and paid in the past period. The programme then reimburses 75% or 85% of the total eligible expenditure declared by each partner – ensuring that 25% or 15% is always provided from other public sources. Project partners therefore need to set aside sufficient liquidity if they are to become involved in an INTERREG IVC project.

Interregional Cooperation under Convergence and Competitiveness programmes

According to the Council Regulation (EC) No 1083/2006 Article 37 §6 (b), some regions may have foreseen a priority on interregional cooperation within their regional Convergence or Competitiveness Operational Programme. In principle, these regions should develop projects with other regions that have included the same reference to interregional cooperation in their Operational Programme. For cooperation projects under Convergence or Competitiveness programmes, each will have its own contract with its own Managing Authority. As this offers significant coordination challenges across the partnership, this type of initiative should be dedicated to intensive cooperation projects with a limited number of regions.

It may occur that the above regions have to work with partners which do not have such a reference to interregional cooperation in their Operational Programme. In this case and in order to avoid additional complexity, it is strongly recommended that all the partners of the project apply to INTERREG IVC ensuring that no partner is in receipt of funding from its regional Convergence or Competitiveness Operational Programme.

In exceptional cases and if duly justified, some regions may use their regional funding to be involved in a project submitted to the INTERREG IVC programme. They would not receive any INTERREG IVC funding, but would instead finance their participation with the budget of their regional programme, which would be listed as "other funding" in the INTERREG IVC application. The following conditions will apply to these particular projects:

- The region funded by its Operational Programme cannot be the Lead Partner of the INTERREG IVC project. The Lead Partner bears all the administrative, financial and legal responsibility (see section 2.3.4) for the implementation of the project. This is the reason why the Lead Partner has to be a 'full' partner in the project.
- Besides the partner(s) funded from the regional programme, the partnership has to involve at least two more partners which are from two other EU Member States and actually financed by the INTERREG IVC programme.
- At least three partners who are from two other EU Member States and funded under INTERREG IVC.
- A partner has to be financed either under INTERREG IVC or under the regional programme, but not under both programmes at the same time. It should also be stressed that expenditure can only be financed from one funding source.
- The deadlines, approval and reporting procedures of the regional programmes will differ from the INTERREG IVC programme and thus make the management of the activities of partners under different funding mechanisms complex. This should be taken into consideration when the project is set up.

Partners from Norway are not eligible to receive ERDF, but can receive funding of 50% from pre-allocated national funds, which Norway makes available in the context of its direct participation in the INTERREG IVC programme. The Norwegian national funds are also disbursed by the INTERREG IVC programme following the submission and acceptance of the projects' progress reports.

2.3.2.2. Funding for partners and activities outside the EU Member States

Partners coming from countries outside the EU territory can participate with their own funding.

Partners from Norway are eligible for Norwegian funding provided by the INTERREG IVC programme. Switzerland has also reserved some funding which is directly provided by the Cantons. Further information can be requested through the Swiss INTERREG National Contact Point.

In some cases it might be possible to obtain funding through other EU-instruments (such as ENPI⁵ or IPA⁶) or through special national allocations. In case of co-financing from other EU instruments, the following has to be kept in mind:

- The financing provided by other instruments has to follow separate administration and monitoring, even if the project has been designed as a joint one.
- The approval deadlines and the administrative procedures of the different instruments vary and might not be in phase with the INTERREG IVC cycle. This should therefore be carefully considered by the partners when planning activities and budgeting costs.
- From the point of view of accountancy an item of expenditure can be allocated to only one programme. Actions budgeted and paid for by EU-partners and Norway and co-financed from the ERDF or the Norwegian allocation are reported to the INTERREG IVC programme. Other parts of the project budgeted and financed by other non-EU partners under other instruments, have to be monitored by the respective other management bodies.

Based on Article 21 of Regulation (EC) No 1080/2006, expenditure incurred in implementing parts of the projects outside the EU especially in countries eligible to receive IPA funds, can be co-financed if they are for the benefit of the project and do not exceed 10% of the project's INTERREG IVC budget. The expenditure has to be budgeted, paid and borne by the EU or Norwegian partners. The related activity has to be explicitly mentioned and justified in the approved application. Usually the activity outside the EU is linked to the official participation of a non EU-partner in the project and allows the EU-partners to take over part of the non EU-partner's costs to facilitate its participation.

Please note that travel costs for EU-partners travelling to places outside the EU do not fall under the 10% rule mentioned above, but are eligible as any other travel costs (provided that the related activity has been foreseen and justified in the application).

2.3.2.3. Co-financing statement

At the application stage, the INTERREG IVC programme requires proof that the Lead Partner and the partner's own co-financing amount has been secured and will be available for the project's implementation as laid out in the application form. This proof is delivered in the form of a co-financing statement. The co-financing statement is obligatory for all partners listed in the application form, i.e. for both EU and non-EU partners. It is a pre-requisite for a project to be eligible to the programme. It is therefore important to take this requirement into account early on in the preparation phase so that the co-financing statement is available at the latest before the closure of the call when the application has to be submitted to the JTS. The template for the co-financing statement is available with the application pack on the programme's website (www.interreg4c.eu).

Further requirements for the co-financing statement are outlined in sections 3.3 and 3.4 of this Programme Manual.

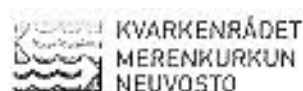
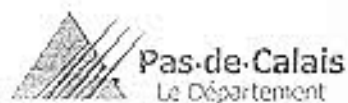

MEMORANDUM OF UNDERSTANDING

ON

EUROPEAN STRAITS INITIATIVE (ESI)

WITH REGARD TO the geographical discontinuity of the local authorities on either side of Straits, increasingly concentrated economic and transportation flows – and therefore environmental risks – linked especially to the significant development of cross-border conurbations, means that the transformation of Straits into economic gateways substantially changes their overall dynamic.

WHEREAS the capacity of Straits to be relevant stakeholders in future development is not supported by any specific European developmental or financial instruments.

WITH REGARD TO the strong involvement of local authorities in European territorial cooperation programmes, amongst which INTERREG IV A, IV B and IV C, and the long experience of the parties concerned in cross border cooperation since 1992,

WHEREAS the general framework of those programmes does not meet the expectations of these local authorities whose particular circumstances are linked to their specific geographical situation bordering national and binational Straits,

WITH REGARD TO current territorial cohesion policy which is targeted on non-maritime and non-coastal areas,

WHEREAS Straits are both maritime and coastal areas with the characteristic of being separate hinterland territories sharing common maritime areas.

WITH REGARD to the integrated maritime policy, currently under review, which aims to integrate all aspects of coastal policies along the 70,000 km of European coastline,

WHEREAS the majority of coastal and territorial policies as regards economy, environment, migration, transport are focused on Straits which makes them privileged observatories and laboratories for the implementation of such policies.

THEREFORE

Several local authorities decided to come together

During summer 2009 Kent County Council (Kent) and the Conseil Général du Pas-de-Calais (Pas-de-Calais) invited local authorities (mostly NUTS 2 and 3 level) to express their interest in the issue.

During autumn 2009, Euregio Tallinn-Helsinki invited Pas-de-Calais for a European meeting at Rail Baltica in Tallinn, in presence of the European Commission.

It was then decided to organise a first technical meeting on 15 and 16 March 2010 in Arras (France) aimed at the development of a common project and to share views on the issues faced by Straits.

Following that, a second technical meeting took place on 27, 28 and 29 September in Messina (Italy). This technical meeting on the one hand integrated new partners, and on the other hand strengthened the wish of the parties to formalise an agreement.

The parties to this Memorandum of Understanding agree on the following:

Article 1 – General aims

This Memorandum of Understanding is aimed at:

- 1- Gaining recognition of the particular characteristics of European Straits within European policies and integrating these within European programmes and European Structural Funds for 2014-2020;
- 2- Working for the emergence of cooperation projects, either through INTERREG programmes or other European programmes, developing mutual cooperation and implementing common actions and projects, in order to promote economic development, coastal protection, transportation and logistics, intercultural working and tourism activities.

Article 2 – Implementation

This Memorandum will be implemented through:

- the organisation of meetings with relevant European Union institutions and networks
- the submission of an INTERREG IV C bid in 2011, whose lead partner will be the Conseil Général du Pas-de-Calais
- any other relevant actions.

Article 3 – Management of the Memorandum

This Memorandum will be managed by at least one annual meeting composed of the relevant representatives of each party.

Each meeting will establish the date and location of the following meeting.

Article 4 – Communication and dissemination

Each party is responsible for sending this Memorandum of Understanding to relevant local, national and European authorities.

Article 5 – Ratification

The present Memorandum is subject to ratification by each party.

Article 6 - Duration of the Memorandum of Understanding

This Memorandum is of four years' duration following its signature and may be jointly renewed by the parties.

The Memorandum may be amended and modified by the parties by written amendment.

Article 7 – Principles

The preambles form an integral part of this Memorandum.

The parties are free to enter into cooperation with third parties not involved in this Memorandum.

New parties may enter into the Memorandum with approval from the majority of the parties.

A party may withdraw its membership by sending a letter to the members of the partnership.

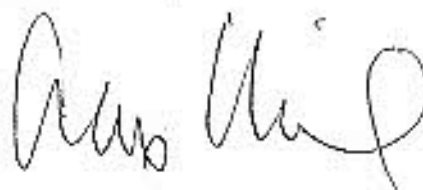

1- THEMATIC PRIORITIES

Economic Development

- Key issue: Demonstrate that the geographical discontinuity represents an "added value" to multiply opportunities and knowledge and to promote the straits as joint cross-border economic systems.
- Objective: promote economic development of the common area through the collaboration between various actors such as universities, administrations, companies, cultural connexions, etc.
- Outputs: best practices database and policy recommendations, common database of actions to promote economic development across the straits

Transport

- Key issue: Straits are places of commercial traffic, traffic of passengers and freight which are crucial for the economic development of the area and need to preserve the biodiversity.
In what way the choice of the crossing infrastructure (channel, ferries, bridges, ...) will help meeting both expectations: economic development and preservation of biodiversity ?
- Objective: Promoting "Innovative tools" to improve point-to-point maritime transport considering the straits inhabitants needs, the commercial and environmental issues.
 - ⇒ Sub-objectives: exchanges of knowledge on how to have the synergy and combine economic development and preservation of biodiversity
- Outputs: best practices manual/dynamic common database and policy recommendations; a network of experts on straits

Biodiversity

- Key issue: Assisting new approaches of implementation to planning and designing the straits marine environment considering landscapes and seascapes as protected "public" heritage to improve the straits inhabitants' quality of life.
- Objective: How to take into account the planning and the development of straits in order to ensure the preservation of biodiversity and the inhabitants' quality of life?
- Outputs:
 - Exchanges of experiences, policy recommendations (ie : data collection)
 - Common action plans
- Results: raise awareness of the transnational aspect of straits and the necessity to develop common models of management

Section 2: Detailed Description of the Project

2.1 Rationale

2.1.1 Brief history of the project

Please describe how the project idea and partnership was developed and how the partners were involved in developing the project proposal.

During summer 2009, on the joint initiative of Pas-de-Calais County Council and Kent County Council, all local authorities bordering a strait in Europe have been contacted and proposed to try and find ways of working together. This solicitation was followed by a first meeting between Pas-de-Calais County Council and Euregio (Helsinki-Tallinn) in November 2009 at a rail Baltica round table.

In the meanwhile most local authorities contacted expressed their strong interest in having a first technical meeting. The latter took place in March 2010 in Arras (Pas-de-Calais) and gathered 14 local authorities. It was then decided a twofold strategy:

- working for the recognition of the straits specificities and the issues they face;
- developing cooperation projects in general and submitting an INTERREG IVC bid in particular.

A second technical meeting was held in Messina (Italy) in September 2010 which was dedicated to the first discussions on the content of such a project. It also was the

opportunity to decide to organise a political meeting in order to sign a Memorandum of Understanding which would state the two objectives mentioned above and thus officialise the partnership. This event took place on November 23rd, 2010. 15 local authorities bordering 8 straits of Europe signed the MoU. On that date, another technical meeting took place as well which helped define more precisely the types of activities needed to be implemented in the framework of the project. Partners were asked to submit concept papers on their expectations and those papers have been discussed during a 4th meeting in January 2011 in Brussels. The partners have kept exchanging information and working on the content of the project via emails and during technical meetings since March 2010. Though there is no strait in Eastern Europe, an Eastern partner has been found to fulfil programme requirements. An opportunity was to make a link with another INTERREG IVC project, DELTANET, which has many

similarities with the NOSTRA project. Indeed, they are both networks of regions with a geographic specificity (deltas and straits) and both projects deal with the issue of joint and often bi-national governance tools.

The Rumanian partner of DELTANET, the Danube Delta National Institute, who agreed to join in the project, also has the advantage of being specialized in the issue of preservation of biodiversity.

2.1.3 Objectives of the project

Please describe the overall objective and sub-objectives of the project.

The overall objective of the project is to show how a joint governance of straits can ensure better public policies in respect to the preservation of biodiversity and natural heritage and thus allow a sustainable economic development of the area.

The partners wish to improve their knowledge of the other straits of Europe and in particular study the different governance tools that may have been implemented or are in project and which have allowed a better management of the strait areas.

It is foreseen that an integrated approach of straits issues is the key answer to most problems these areas have to face. Therefore, the identification of best practices should enable the partnership to convince regional, national and European policy makers of the necessity of enhancing such an integrated approach. This project should contribute to reach the EU 2020 strategy objectives of an intelligent, sustainable and inclusive growth in those areas.

Considering the wide range of issues tackled by straits and in order to simplify the analysis of good practices, it has been chosen to focus on four sub-objectives, which are:

- to improve point-to-point maritime transport and logistics through innovative tools considering the straits inhabitants needs, the commercial and environmental issues;
- to promote economic development of the common area through a tight collaboration between all actors (local authorities and administrations, schools and universities, enterprises, cultural organisations, civil society, etc...)
- to ensure the preservation of biodiversity and the inhabitants' quality of life through a better planning and development of straits areas.
- To raise the inhabitants' consciousness of belonging to a same area and thus develop a strait identity.

This will be done through the exchange and analysis of best practices during study visits, seminars, workshops and conferences, which will lead to the production of priorities recommendations for regional, national and European policies and the conception of implementation plans by each partner.

The Province of Messina lies along one of the two sides of the Strait of Messina and in front of the Province of Reggio Calabria. The hydrogeological conditions of the Strait of Messina are peculiar and its flora and fauna are equally uncommon. The strait is characterised by an extraordinary ecosystem and to preserve it strategies of protection and conservation of native and endemic species have been implemented. The element of force is now and will be in the next future the synergy between the research community and local government that will implement conservation measures based on scientific data. A threat to the environment are mainly transport and economic activities shown on this strip of sea. The Province of Messina is able to directly influence regional and local policies as the time plays an important role in strategic planning and programming with the Sicilian Region and the municipalities that fall within its territory. The planning activities cover all areas of life

including the environment and risk prevention.
